Possum & Pigeon Inspections

Should there be evidence of possums or pigeons at your property, we can arrange a thorough inspection and report at a cost of \$198. The pest control company we use can also provide a quote (as required) within 24 hours of the inspection.

Possums can cause significant damage to your property. They chew through electrical wires, which can lead to a risk of an electrical fire.

They can also damage your insulation, wooden beams and roofing materials.

Over time, their urine and droppings can also cause damage to your ceiling and walls, leading to unpleasant smells and the need for expensive repairs.

If left unchecked, possums can cause extensive damage to your property, reducing its value & making it unsafe to live in.



Pigeons can cause several problems, including damage to buildings, health risks and possible fire hazards.

- Droppings: Pigeon droppings are acidic & corrosive, which can damage building materials like stonework, brickwork, and metals.
- Nests: Pigeon nests can block flues or chimneys, which can lead to a build-up of gases and smoke and become a fire risk.
- Gutters & drains: Pigeon droppings can clog gutters and drains, which can cause water damage.
- Rooftop equipment: Pigeons can cause damage to air-conditioning units and solar panels.
